8 **ORDER**

9 WHEREAS, on December 7, 2005, New Mexico Supreme Court Order No.
10 05-8500 was issued reauthorizing the existence and operation of the Judicial
11 Information Systems Council (JIFFY), and on October 30, 2020, New Mexico
12 Supreme Court Order No. 20-8100 was issued reorganizing and renaming JIFFY as
13 the Judicial Technology Council (JTech);

14 WHEREAS, on April 6, 2023, New Mexico Supreme Court Order No. 23-
15 8100 was issued reorganizing and renaming the Judicial Technology Council
16 (JTech) as the Judicial Technology Committee and requesting the nomination of
17 members; and

18 WHEREAS, this matter came on for consideration upon the Court's own
19 motion to revert the name of the Judicial Technology Committee back to the Judicial
20 Technology Council (JTech) and to appointment members, and the Court being
21 sufficiently advised, Chief Justice C. Shannon Bacon, Justice Michael E. Vigil,

1 Justice David K. Thomson, Justice Julie J. Vargas, and Justice Briana H. Zamora
2 concurring;

3 NOW, THEREFORE, IT IS ORDERED that the Judicial Technology
4 Committee shall be renamed the Judicial Technology Council (JTech);

5 IT IS FURTHER ORDERED that Hon. Jane C. Levy, Cassandra Hayne, Levi
6 Yates, Lisa O'Grady, and Jodie Schwebel are appointed to JTech as voting members
7 for initial three-year terms, said terms to expire December 31, 2026;

8 IT IS FURTHER ORDERED that Hon. J. Hofacket, Hon. D. Hunter, Anthony
9 Maloney, and Brittney Aguilar are appointed as voting members, and Ian Belzpalco
10 as a non-voting member, to JTech for initial two-year terms, said terms to expire
11 December 31, 2025;

12 IT IS FURTHER ORDERED that all members named herein are eligible to
13 serve two full three-year terms upon the expiration of their current terms;

14 IT IS FURTHER ORDERED that Hon. Jane C. Levy shall continue to serve
15 as Chair of JTech until further order of the Court;

16 IT IS FURTHER ORDERED that all other terms in this Court's April 6, 2023,
17 order renaming and reorganizing JTech shall continue to apply; and


1 IT IS FURTHER ORDERED that this order shall be effective immediately.
