17 WHEREAS, this matter came on for consideration to adopt new Rule 23-
18 106.2 NMRA of the Supreme Court General Rules, to amend Rules 23-106 and 23-
19 106.1 NMRA of the Supreme Court General Rules, and to withdraw Rule 1-083
20 NMRA of the Rules of Civil Procedure for the District Courts and Rule 5-102
21 NMRA of the Rules of Criminal Procedure for the District Courts, and the Court
22 having considered the recommendation and being sufficiently advised, Chief Justice
23 David K. Thomson, Justice Michael E. Vigil, Justice C. Shannon Bacon, Justice Julie
24 J. Vargas, and Justice Briana H. Zamora concurring;

1 NOW, THEREFORE, IT IS ORDERED that new Rule 23-106.2 NMRA is
2 ADOPTED;

3 IT IS FURTHER ORDERED that the amendment of Rules 23-106 and 23-
4 106.1 NMRA is APPROVED;

5 IT IS FURTHER ORDERED that Rules 1-083 and 5-102 NMRA are
6 WITHDRAWN;


7 IT IS FURTHER ORDERED that the above-referenced amendments shall be
