10 Thomson, Justice Michael E. Vigil, Justice C. Shannon Bacon, Justice Julie J.
11 Vargas, and Justice Briana H. Zamora concurring;

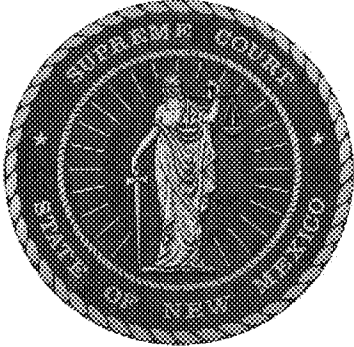
12 NOW, THEREFORE, IT IS ORDERED that the amendment of Rules 1-006,
13 2-104, 3-104, 5-104, 6-104, 7-104, 8-104, 10-107, and 12-308 NMRA is
14 APPROVED;

16 **effective December 31, 2024**; and


17 IT IS FURTHER ORDERED that the Clerk of the Court is authorized and
