29 WHEREAS, this matter came on for consideration upon recommendation of
30 Court staff to amend Rule 2-101 NMRA of the Rules of Civil Procedure for the
31 Magistrate Courts, Rule 3-101 NMRA of the Rules of Civil Procedure for the

1 Metropolitan Courts, Rule 5-101 NMRA of the Rules of Criminal Procedure for the
2 District Courts, Rule 6-101 NMRA of the Rules of Criminal Procedure for the
3 Magistrate Courts, Rule 7-101 NMRA of the Rules of Criminal Procedure for the
4 Metropolitan Courts, Rule 8-101 NMRA of the Rules of Procedure for the Municipal
5 Courts, Rule 12-405 NMRA of the Rules of Appellate Procedure, Uniform Jury
6 Instructions 14-631 and 14-1630 NMRA of the Uniform Jury Instructions-Criminal,
7 and Rule 24-101.1 NMRA of the Rules Governing the New Mexico Bar, and the
8 Court having considered the recommendation and being sufficiently advised, Chief
9 Justice David K. Thomson, Justice Michael E. Vigil, Justice C. Shannon Bacon,
10 Justice Julie J. Vargas, and Justice Briana H. Zamora concurring;

11 NOW, THEREFORE, IT IS ORDERED that the amendment of Rules 2-101,
12 3-101, 5-101, 6-101, 7-101, 8-101, 12-405, and 24-101.1 NMRA, and Uniform Jury
13 Instructions 14-631 and 14-1630 NMRA is APPROVED;

14 IT IS FURTHER ORDERED that the above-referenced amendments shall be
15 **effective December 31, 2024**; and


16 IT IS FURTHER ORDERED that the Clerk of the Court is authorized and
