WHEREAS, this matter came on for consideration upon recommendation of
the Rules of Civil Procedure for State Courts Committee, the Rules of Criminal

2 Committee to reinstate and amend Rule 1-093 NMRA of the Rules of Civil
3 Procedure for the District Courts, Rule 2-110 NMRA of the Rules of Civil Procedure
4 for the Magistrate Courts, Rule 3-110 NMRA of the Rules of Civil Procedure for the
5 Metropolitan Courts, Rule 5-112 NMRA of the Rules of Criminal Procedure for the
6 District Courts, Rule 6-111 NMRA of the Rules of Criminal Procedure for the
7 Magistrate Courts, Rule 7-111 NMRA of the Rules of Criminal Procedure for the
8 Metropolitan Courts, Rule 8-110 NMRA of the Rules of Procedure for the Municipal
9 Courts, Rule 10-169 NMRA of the Children's Court Rules and Forms, and Form 9-
10 611 NMRA of the Criminal Forms, and to amend Forms 9-612, 9-614, and 9-615
11 NMRA of the Criminal Forms, and the Court having considered the recommendation
12 and being sufficiently advised, Chief Justice David K. Thomson, Justice Michael E.
13 Vigil, Justice C. Shannon Bacon, Justice Julie J. Vargas, and Justice Briana H.
14 Zamora concurring;

15 NOW, THEREFORE, IT IS ORDERED that the reinstatement and
16 amendment of Rules 1-093, 2-110, 3-110, 5-112, 6-111, 7-111, 8-110, and 10-169
17 NMRA and Form 9-611 NMRA is APPROVED;

18 IT IS FURTHER ORDERED that the amendment of Forms 9-612, 9-614, and
19 9-615 NMRA is APPROVED;


1 IT IS FURTHER ORDERED that the above-referenced amendments shall be
