22   **ORDER**

23                   WHEREAS, this matter came on for consideration upon recommendation of  
24 the Rules of Civil Procedure for State Courts Committee to adopt new Forms 4-  
25 226A, 4-301A, and 4-805C NMRA of the Civil Forms; to reinstate and amend Form  
26 4-805B NMRA of the Civil Forms; and to amend Rules 1-009, 1-055, 1-060, 1-  
27 065.1, and 1-065.2 NMRA of the Rules of Civil Procedure for the District Courts,  
28 Rules 2-201, 2-702, 2-703, 2-801, and 2-802 NMRA of the Rules of Civil Procedure

1 for the Magistrate Courts, Rules 3-201, 3-702, 3-704, 3-801, and 3-802 NMRA of  
2 the Rules of Civil Procedure for the Metropolitan Courts, and Forms 4-801, 4-801A,  
3 4-808, 4-808A, and 4-809 NMRA of the Civil Forms, and the Court having  
4 considered the recommendation and being sufficiently advised, Chief Justice David  
5 K. Thomson, Justice Michael E. Vigil, Justice C. Shannon Bacon, Justice Julie J.  
6 Vargas, and Justice Briana H. Zamora concurring;

7 NOW, THEREFORE, IT IS ORDERED that new Forms 4-226A, 4-301A,  
8 and 4-805C NMRA are ADOPTED;

9 IT IS FURTHER ORDERED that the reinstatement and amendment of Form  
10 4-805B NMRA is APPROVED;

11 IT IS FURTHER ORDERED that the amendment of Rules 1-009, 1-055, 1-  
12 060, 1-065.1, 1-065.2, 2-201, 2-702, 2-703, 2-801, 2-802, 3-201, 3-702, 3-704, 3-  
13 801, and 3-802 NMRA, and Forms 4-801, 4-801A, 4-808, 4-808A, and 4-809  
14 NMRA is APPROVED;

15 IT IS FURTHER ORDERED that the above-referenced amendments shall be  
16 **effective December 31, 2025**; and


17 IT IS FURTHER ORDERED that the Clerk of the Court is authorized and
