16   **ORDER**

17               WHEREAS, this matter came on for consideration upon recommendation of  
18 the Uniform Jury Instructions – Criminal Committee to adopt new UJI 14-5062,  
19 14-6002A, and 14-6002B NMRA, to amend UJI 14-140, 14-985, 14-1630, 14-  
20 1632, 14-1633, 14-1642, 14-1697, 14-1701, 14-2204, 14-2205, 14-2206, 14-2207,  
21 14-2209, 14-2240, 14-2801, 14-2810, 14-2817, 14-2821, 14-4320, 14-4321, 14-  
22 5170, 14-5173, 14-5174, and 14-6012 NMRA, and to withdraw UJI 14-250, 14-  
23 625, and 14-6002 NMRA of the Uniform Jury Instructions – Criminal, and the  
24 Court having considered the recommendation and being sufficiently advised, Chief  
25 Justice Michael E. Vigil, Justice Barbara J. Vigil, Justice Judith K. Nakamura,  
26 Justice C. Shannon Bacon, and Justice David K. Thomson concurring;

NOW, THEREFORE, IT IS ORDERED that new UJI 14-5062, 14-6002A, and 14-6002B NMRA are ADOPTED;

IT IS FURTHER ORDERED that the amendment of UJI 14-140, 14-985, 14-1630, 14-1632, 14-1633, 14-1642, 14-1697, 14-1701, 14-2204, 14-2205, 14-2206, 14-2207, 14-2209, 14-2240, 14-2801, 14-2810, 14-2817, 14-2821, 14-4320, 14-4321, 14-5170, 14-5173, 14-5174, and 14-6012 NMRA is APPROVED;

IT IS FURTHER ORDERED that UJI 14-250, 14-625, and 14-6002 NMRA are WITHDRAWN;

IT IS FURTHER ORDERED that the above-referenced amendments shall be **effective for all cases pending or filed on or after December 31, 2020**; and

IT IS FURTHER ORDERED that the Clerk of the Court is authorized and directed to give notice of the above-referenced amendments by publishing them in the *Bar Bulletin* and *New Mexico Rules Annotated*.
