

1 **14-381. Assault; attempted battery with intent to commit a violent felony; “household**  
2 **member”;** essential elements.

3 For you to find the defendant guilty of assault with intent to [kill] [or]<sup>1</sup> [commit  
4 \_\_\_\_\_]<sup>2</sup> [as charged in Count \_\_\_\_]<sup>3</sup>, the state must prove to your satisfaction beyond a  
5 reasonable doubt each of the following elements of the crime:

6 1. The defendant intended to commit the crime of battery against \_\_\_\_\_ (*name*  
7 *of victim*) by \_\_\_\_\_<sup>4</sup>;

8 A battery consists of intentionally touching or applying force in a rude, insolent or angry  
9 manner.<sup>5</sup>

10 2. The defendant began to do an act which constituted a substantial part of the battery  
11 but failed to commit the battery;

12 3. The defendant also intended to [kill] [or]<sup>1</sup> [commit \_\_\_\_\_]<sup>2</sup> on \_\_\_\_\_  
13 (*name of victim*);

14 4. \_\_\_\_\_ (*name of victim*) was a household member of the defendant<sup>6</sup>;

15 5. This happened in New Mexico on or about the \_\_\_\_ day of \_\_\_\_\_, \_\_\_\_.

#### USE NOTES

18 1. Use only the applicable bracketed alternatives.

19 2. Insert the name of the felony or felonies in the disjunctive. This instruction is to be  
20 used for assault against a household member with intent to kill or to commit a violent felony, *i.e.*,  
21 mayhem, criminal sexual penetration, robbery, or burglary. The essential elements of the felony  
22 or felonies must also be given immediately following this instruction. To instruct on the elements  
23 of an uncharged offense, UJI 14-140 NMRA must be used. For mayhem, *see* UJI 14-314 NMRA.

1 For criminal sexual penetration in the first, second, or third degree, *see* UJI§ 14-941 [~~NMRA~~] to  
2 [~~UJI~~] 14-961 NMRA. For robbery, *see* UJI 14-1620 NMRA. For burglary, *see* UJI 14-1630  
3 NMRA.

4 3. Insert the count number if more than one count is charged.

5 4. Use ordinary language to describe the touching or application of force.

6 5. If the “unlawfulness” of the act is in issue, add unlawfulness as an element as  
7 provided by Use Note 1 of UJI 14-132 NMRA. In addition, UJI 14-132 NMRA is given. If the  
8 issue of “lawfulness” involves self defense or defense of another, *see* UJI§ 14-5181 [~~NMRA~~] to  
9 [~~UJI~~] 14-5184 NMRA.

10 6. Definition of a household member should be given, *see* UJI 14-370 NMRA.
