17 **ORDER**

18 WHEREAS, this matter came on for consideration upon recommendation of
19 the Domestic Relations Rules Committee to adopt new Rules 1-150, 1-151, 1-152,
20 1-153, 1-154, 1-155, and 1-156 NMRA of the Rules of Civil Procedure for the
21 District Courts, to adopt new Forms 4A-514, 4A-515, 4A-516, and 4A-517 NMRA
22 of the Domestic Relations Forms, and to amend Forms 4A-501, 4A-502, 4A-503,
23 4A-504, 4A-505, 4A-506, 4A-507, 4A-508, 4A-509, 4A-510, 4A-511, 4A-512, and
24 4A-513 NMRA of the Domestic Relations Forms, and the Court having considered
25 the recommendation and being sufficiently advised, Chief Justice C. Shannon

1 Bacon, Justice Michael E. Vigil, Justice David K. Thomson, Justice Julie J. Vargas,
2 and Justice Briana H. Zamora concurring;

3 NOW, THEREFORE, IT IS ORDERED that new Rules 1-150, 1-151, 1-152,
4 1-153, 1-154, 1-155, and 1-156 NMRA and new Forms 4A-514, 4A-515, 4A-516,
5 and 4A-517 NMRA are ADOPTED;

6 IT IS FURTHER ORDERED that the amendments to Forms 4A-501, 4A-502,
7 4A-503, 4A-504, 4A-505, 4A-506, 4A-507, 4A-508, 4A-509, 4A-510, 4A-511, 4A-
8 512, and 4A-513 are APPROVED;


9 IT IS FURTHER ORDERED that the above-referenced amendments to the
10 NMRA shall be **effective December 31, 2022**; and

11 IT IS FURTHER ORDERED that the Clerk of the Court is authorized and
12 directed to provide notice of the above-referenced amendments on the Supreme
13 Court's public website and in the *Bar Bulletin* and to publish the amendments in the
14 *New Mexico Rules Annotated*.
