18 WHEREAS, this matter came on for consideration upon recommendation of
19 the Rules of Criminal Procedure for State Courts Committee to adopt new Rule 5-
20 502.1 NMRA of the Rules of Criminal Procedure for the District Courts, new Rule
21 6-504.1 NMRA of the Rules of Criminal Procedure for the Magistrate Courts, new
22 Rule 7-504.1 NMRA of the Rules of Criminal Procedure for the Metropolitan
23 Courts, and new Rule 8-504.1 NMRA of the Rules of Procedure for the Municipal
24 Courts, and the Court having considered the recommendation and being sufficiently
25 advised, Chief Justice C. Shannon Bacon, Justice Michael E. Vigil, Justice David K.
26 Thomson, Justice Julie J. Vargas, and Justice Briana H. Zamora concurring;

1 NOW, THEREFORE, IT IS ORDERED that new Rules 5-502.1, 6-504.1, 7-
2 504.1, and 8-504.1 NMRA are ADOPTED;

3 IT IS FURTHER ORDERED that the above-referenced amendments to the
4 NMRA shall be **effective December 31, 2022**; and

5 IT IS FURTHER ORDERED that the Clerk of the Court is authorized and
6 directed to provide notice of the above-referenced amendments on the Supreme
7 Court's public website and in the *Bar Bulletin* and to publish the amendments in the
8 *New Mexico Rules Annotated*.
