10 **USE NOTES**

11 1. The court can extend jurisdiction over a fostering connections case for a period not
12 to exceed one (1) year from the eligible adult's twenty-first birthday only if the court finds that the
13 department has not made active efforts, termination of jurisdiction would be harmful to the eligible
14 adult, and the eligible adult consents to jurisdiction of the court. The court may dismiss the case
15 for good cause any time after the eligible adult's twenty-first birthday.
